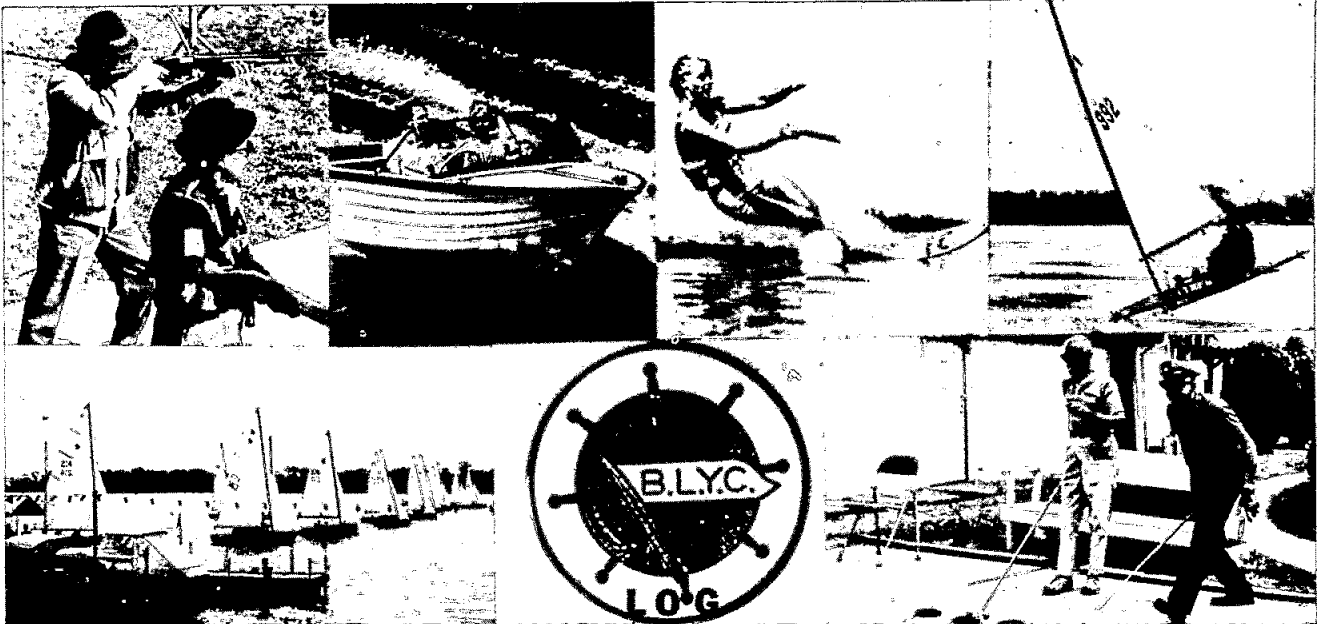

COMMODORE COMMENTS:

Sunday, Sept. 15, 1968, will never be forgotten! Two such high honors on a single day make it difficult to express my feelings. Receiving the Heber Award makes one most humble, and it will only make me strive to live up to the principles on which it is awarded. I will certainly make every effort to carry on the fine tradition that goes with this distinction. And as new Commodore, I look to you for help in advancing the interests of the Club.

Sunday was quite a day for BLYC, also. The membership elected an excellent Board of Governors. We have already had two meetings and are working intensely on current problems facing the Club.

Appointments have been made and are listed elsewhere in this issue. All Governors have demonstrated a willingness to serve which is always evident in men of good will. Their acceptance of assigned duties predicts a good year ahead, with a continuation of cooperative effort which will continue to exist in your new administration. Their projected functions this year will most certainly require them to call upon you as a member to help serve in many areas of activity. I trust you will take this opportunity to share in the responsibilities. The benefits derived from having many members put forth effort include: knit together the membership; promote fellowship; and further develop a sense of common endeavor.

A new committee will be functioning this year, and I hope it will become one of the Standing Committees required in the By-Laws. The title of this committee is GRIEVANCE COMMITTEE. It will accept from any member a written grievance properly signed by the member. An investigation will be carried through by this committee, and their findings will be reported directly to the Board of Governors for final disposition. The member submitting the grievance will be given the oppor-

tunity to appear in his own behalf, if he so desires. The Grievance Committee will be granted investigative powers only. Any member asked to contribute knowledge of the grievance is urged to cooperate with them. The members of this committee are listed in this issue with the appointments.

Two other new positions have been inaugurated this year: JUDGE ADVOCATE AND PARLIMENTARIAN. Appointments listed elsewhere.

In the tradition of B.L.Y.C.: At the August meeting the Board of Governors adopted another old yacht club tradition, presently in other clubs of our type, as an appropriate action for B.L.Y.C. A permanent Commodore's Table in the dining room was established as a focal point for fellowship among members new and old. In setting aside the Commodore's table, the Governors felt that all members would be given the opportunity to pay their respects to the highest office of our Club, and to hear informally about the progress of administration. A Commodore's lamp and ensign will identify this special table on the occasions it is reserved for this function. It will be reserved during all dances, other scheduled events and weekends. Members will join the Commodore, at his invitation and will sign the Commodore's Guest Book. (Invitees will, however, pay their own bills.)

As our Club grows, and our activities increase, traditional customs help us communicate with one another, help increase our enjoyment of common interests and help us unify our purpose as members of the Club. I hope the Board of Governors will continue to seek ways to accomplish these objectives.

**BULLETIN - to all members

On Friday, 13th, (an appropriate date) the Club was visited by State Liquor Agents. Several items were confiscated and a citation issued to our Club. More information follows. Please cooperate.

Special Board Meetings 9-19-68 and 9-22-68

The meetings involved a deep discussion into the various aspects of the laws of the State of Ohio, related to the sale of beer and spirituous liquor. We are most grateful for the explanations given us by an enforcement officer from the Liquor Department. Basically, our previous permit allowed the sale of low-powered beer only, and did not allow any liquor on the premises. This permit has now been returned to the Department of Liquor Control for cancellation, and a study was made regarding our position under the law: with a permit of a different type as opposed to no permit whatever. Then the Board voted to apply for a D-4 (Club) liquor permit. The issuance of this permit usually takes 4 to 6 weeks to obtain. Under this type permit there are problems which must be resolved and rules established. We will make every effort to keep you informed as to the progress of our deliberations and you can be assured every effort is being made to arrive a proper procedures that will not jeopardize the Club in any way, and benefit the largest majority of the membership. 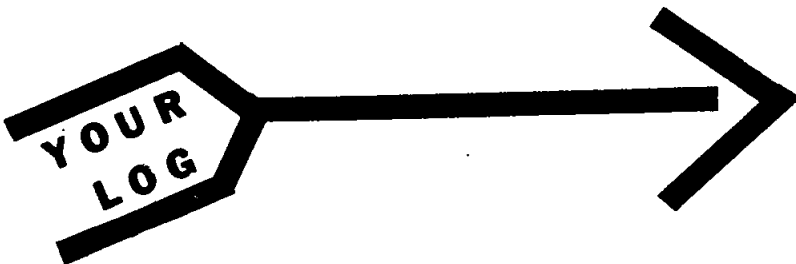
