 TO BE INSERTED AFTER SECTION 6, ARTICLE III, PAGE 12 OF BLYC BY-LAWS:

ARTICLE III-ADDENDUM: DISPENSING AND CONSUMPTION OF ALCOHOLIC BEVERAGES:

Section 1 - The laws of the State of Ohio, Department of Liquor Control are fully recognized, and are specific as to the requirements as they apply to the Class permit issued to the Club. The major provisions of these rules as they apply to the Members are set forth hereafter;

- (a) Beer and alcoholic beverages will be sold ONLY to Members;
- (b) Members may purchase beer and alcoholic beverages for their guests, however the Member may not charge for, or accept compensation for such beverages:
- (c) No Member shall bring beer or alcoholic beverages into the Permit Premises; (as defined in Section 2 of this Article)
- (d) Beer or alcoholic beverages may be brought onto the island by those persons renting sleeping rooms on the second floor of the Club building or directly to boats moored at Club docks. Such beverage must be consumed in the rooms and may not be taken into the Permit Premises; (as defined in Section 2 of this Article)
- (e) All beer or alcoholic beverages purchased at the Club Bar must be consumed on the Premises and may not be taken from the Premises or Island;
- (f) No Member, or guest, will be served beer or alcoholic beverages if he or she is intoxicated, or appears in the judgement of the bartender, to have consumed an excess;
- (g) No beer will be served to anyone less than 18 years of age. Alcoholic beverages will not be served to anyone less than 21 years of age;
- (h) No alcoholic beverage, other than 3.2% beer will be sold or consumed on the Permit Premises on Sundays, Primary or General Election days;

Article, is defined as the entire first floor of the Club House, including the porches and patio, the Mens' Rest Room and Ladies' Rest Room These Permit Premises, as described, shall not be abridged by the Definition stated in Article III, Section 1, Paragraph (c).

- Section 3 Infraction of the By-Laws, by Members of any Class and/or guests of the member(s) will subject the Member to the following penalties. Provision made for Members held responsible for the conduct of their guests stated in Article III, Section 2, Paragraph (a);
 - (a) Member(s) violating any of the provisions of this Article may be suspended for a period of six (6) months for the initial violation, further;
 - (b) When the same Member violates these provisions the second time he will be expelled from the Club.
- Section 4 Hearing Procedure: Any Member(s) alleged to have violated the provisions of this Article will be given the opportunity for hearing before a Committee consisting of the Board of Trustees and the Commodore.
 - (a) The Committee will determine the validity of the alleged violation on the basis of testimony that may be presented by the Member(s) and/or witnesses;
 - (b) The Committee will report directly to the Board of Governors on its recommendations;
 - (c) If the Member(s) are adjudged to have violated any of these provisions, the Board of Governors will assess the appropriate penalty as set forth in Section 3, (a) or (b);
 - (d) In the event the Member(s) are subject to Paragraph (c) of this Section, the Member(s) will be so notified in writing by the Secretary;
 - (e) In the event the Member(s) is adjudged not having violated any of these provisions, the Secretary shall so notify the Member(s) in writing.

*The following is a complete paragraph from The Ohio Department of Liquor Control newsletter, DOLC NEWS:

"Enforcement agents conducted 79 non-permit raids during the third quarter of 1968. The 376 persons arrested were tried on 441 charges 414 of which were proved. Those found guilty received fines of \$20,430. and jail sentences totaling 1,004 days."

Here is another: "Most frequent citation charges (Permit Holders) were:

Sunday sale, 167 Sales to Minors, 129 Minor drinking offences, 90 Sunday Consumption, 74 Furnishing liquor to minors, 38."

watch for anyone you think is not a member attempting to buy a drink or beer or ticket, and report to Governor in charge;

permit bonified State Liquor enforcement officers to conduct their inspection of our premises;


ask your questions. After the violation, it is too late;
