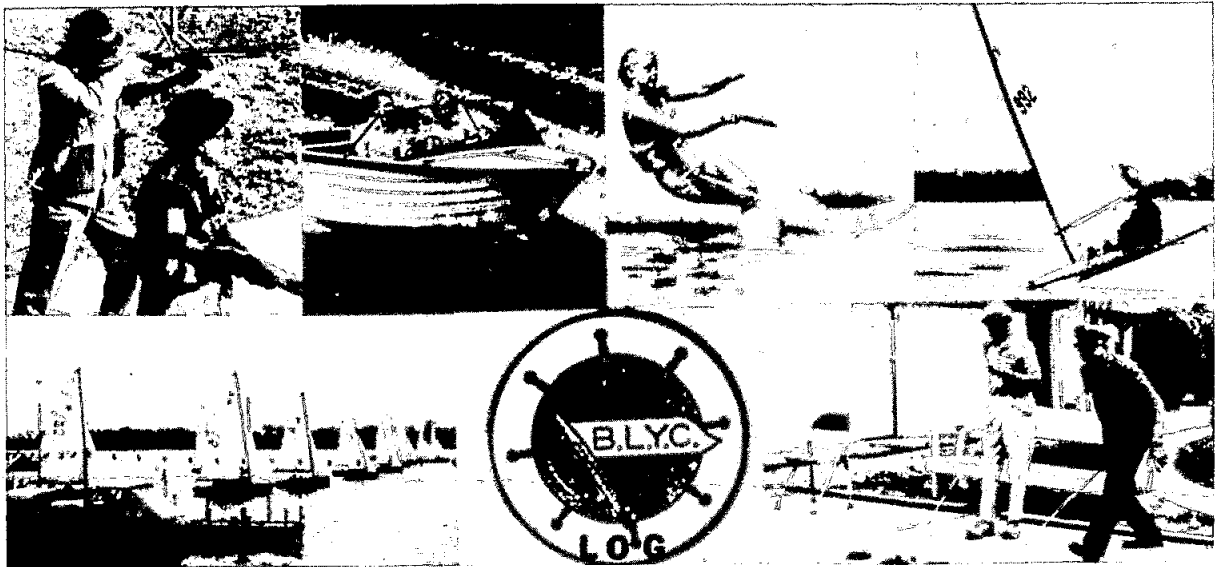

HOUSE COMMITTEE: Mention was made in the September Log suggesting that making advance reservations for the Dining Room would accomplish two worthwhile objectives:

1. Help the kitchen plan the quantity of food needed, and arrange for the necessary help to serve it.
2. Reward the members who do co-operate in this regard by having places in the Dining Room at or about the time requested.

The Dining Room can handle the "reservation" load along with the "no reservation" requirements on most occasions. However, sometimes problems arise on some "special nights" - especially on week-ends when a special affair is planned and the weather-man is good to us.

Some improvement is needed to the present plan. It seems necessary now to add one requirement to the making of the reservation and that is to **STATE THE TIME** table is desired, and be ready to use the table at that time, and in addition to be understanding if a previous diner at that table has not quite finished.

1. Release tables to waiting diners, if there be any, on especially crowded nights, if the table is not used at the time reservation is called for.
2. Let the Club use to the fullest all tables with as much consideration to reservation users as possible, but not to the point of rushing the first users.

This problem won't happen too often, but our obligation is to be fair to as many members as possible and at the same time use our facilities to the fullest without offending anyone.

We want to please the early diners without rushing him and at the same time please the reservation maker with as little waiting as possible -- all of which enables the club to use the Club's facilities to the fullest and to please (we hope) as many members as possible.
