FROM THE BRIDGE: Secretary Governor Jack Beeson has asked the Editor to include here some excerpts from his notes taken at the Orientation Governor's Meeting held October 9, 1969, that pertain to the Commodore's comments to the Board at the meeting.

Commodore Ray Walker welcomed all the governors to this first meeting of the New Administration, and particularly did he make welcome the new members to the Board. He shared with each of the Board Members his views on the responsibility of each of them - including his own.

In response to "what should each of the Board Members do this year" he said:

Commodore's Basic Responsibilities:-

- 1 - Maintain harmony in the Club as No Club divided within itself is worth much to any of the members.
- 2 - See to it that all the work assigned to each Committee is done as, and when it should be. If Commodore unable to get the Governor in charge to carry out his responsibility, to bring the problem to the Board.

Flag Officers' Responsibilities -

- 1 - Learn to become Commodore - by working closely with the Commodore and helping him.
- 2 - Carry out the duties assigned to him in connection with the specific committee he is in charge of.

Governors' Responsibilities -

- 1 - Carry out the duties assigned to him in connection with the specific committee, or committees, he is in charge of.
- 2 - Make all decisions on issues for the Board to decide with the welfare and benefit of the membership as a whole in mind - which includes, but is not limited to, specific groups or personal interest.

At this point, the Commodore made it clear to the Governors that the Membership of the Club expected each of them to do their jobs - and the Commodore had no doubt that each Governor would.

The Commodore stated further that "nothing must stand in the way of each of us getting our job done. If you can't do it, ask for help--we will all help when you ask for it - but not if your job is undone because you don't care and simply walk away from it".

He concluded "You are in jobs of Great Trust-- Great Responsibility -- There is no place on the Board for any man who doesn't care. The members expect great things from us - let's see that they get them".

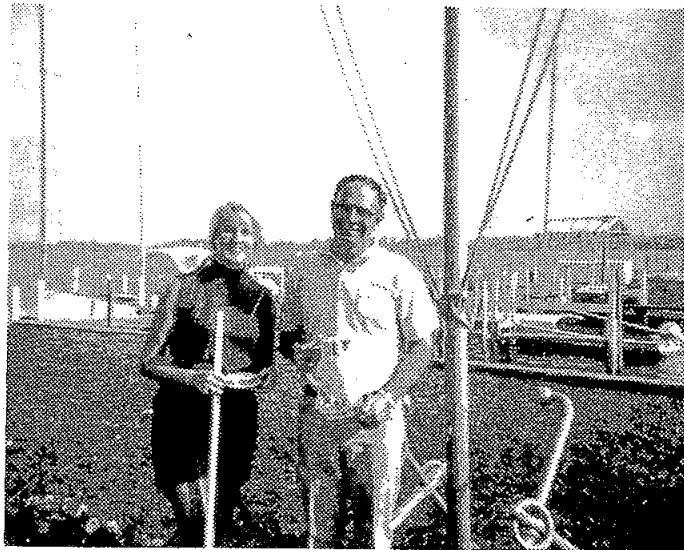
