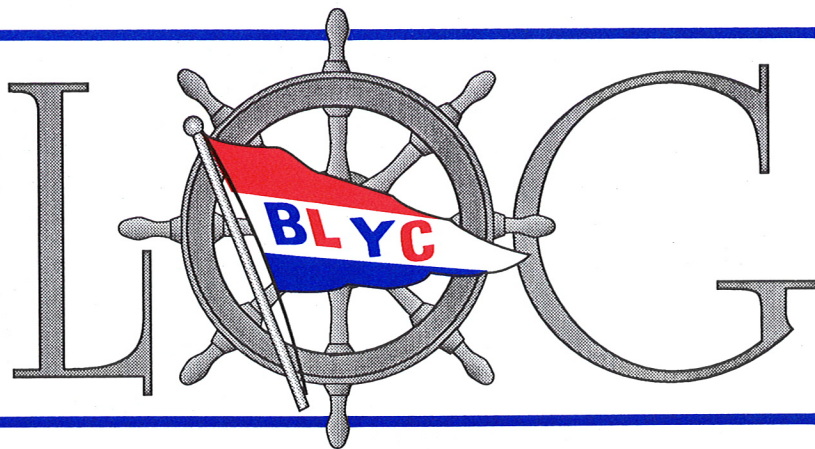

Proposed Amendment to The Constitution of the Buckeye Lake Yacht Club
STAGGERED TWO YEAR TERMS FOR GOVERNORS

The proposal is to change Article VII as follows: [strike through letters indicate deletions, bold letters indicate additions]

Section 1 (b) The Nominating Committee shall nominate not less than ~~twelve candidates for elective officers except that it nominate eleven candidates if the Vice Commodore will automatically become Commodore~~ two more candidates for elective officers than the number of vacancies to be filled on the Board of Governors. [remainder of (b) unchanged.]

Section 2 (c) Each Governor shall be elected for a term of ~~one year~~ two years except as otherwise stated, enough being elected each year to maintain the full membership of the Board of Governors. The terms shall be staggered with at least four terms beginning and ending in odd years and at least four terms beginning and ending in even years, except that the term of the Commodore shall terminate at the annual meeting at the end of his term as Commodore. At each election, the number of candidates elected to two year terms shall be 9 minus the number of terms which will not expire at the election, but not to exceed 5. In the event a Vice Commodore shall automatically succeed to Commodore, his term shall be considered as not expiring until the annual meeting at the end of his term as Commodore. In the event the number of unfilled vacancies on the Board of

Governors to be filled by election exceeds five, the Board of Trustees shall determine, from among those members receiving enough votes to be elected to those vacancies, which of them shall have odd year terms and which shall have even year terms.

Transitional Provisions:

This amendment will become fully effective at the election held two years after its adoption.

Immediately after the election, which occurs one year following the adoption of this amendment, the trustees shall determine which of the elected candidates shall have even-year terms and which shall have odd-year terms, and they shall announce their selection at the annual meeting in connection with their announcement of the elected candidates.

Explanation

The Constitution currently requires all governors to run for reelection each year, except a Vice Commodore who will automatically succeed to Commodore. Over recent years there has been an increasing reluctance by members to serve on the Board of Governors. The result has been fewer members willing to run, an excessive number of people with little club experience being elected, and a high turnover of board members. The provision of a two year term should reduce the burden of running for governor because a governor need do it only every other year. It should

also improve continuity and experience of the Board since only about half the governors are subject to the possibility of change each year.

Because the number of Board members, nine, cannot be divided evenly by two, and because of the complication of a vice commodore automatically succeeding as commodore, we can not simply have exactly half the board elected each year. Consequently, the language is somewhat complicated by an attempt to preserve the principle of electing about half each year while also preserving automatic succession of the Vice Commodore and the number of Board members at nine. The proposed amendment attempts to accommodate likely situations but leaves it up to the Trustees to resolve problems with limits. Either four or five governors would be elected each year to a two year term, depending on how many governors are in the middle of their two year term when an election is held. Provision is also made for election to fill midterm vacancies if not filled by the Board in accordance with the Constitution.

Although not a matter for the Constitution, the annual election porch breakfast has been an important event and should be preserved by action of the Board. For example, they could require both candidates and midterm governors to be on the porch. They could also provide that the club furnishes all the prepared food on the porch.

Proposed Amendment to The Constitution of the Buckeye Lake Yacht Club
GOVERNOR REMOVAL SAFEGUARD

The proposal is to change Article VII, Section 5 as follows: [bold letters indicate addition]

Section 5. Any elective officer of the Club may be removed from office by two-thirds vote of the active and life members in good standing who are present at any regular or special meeting of the Club or by an affirmative vote of at least four of the Trustees at any time.

Explanation

The governors are referred to as elec-

tive officers by the BLYC Constitution. The adoption of staggered two year terms for governors would increase the need to provide a practical way of removing a governor who is not doing his job. The governors cannot be expected to do it because they must run for office, both as governor and for some as a flag officer, so they cannot make enemies. The membership is unlikely to do it because an attempt to do it would create an ugly and embarrassing situation for everyone. As a result, there have been occasions in the past where

a governor has performed poorly or negligently yet no formal action was taken. The Trustees, as a board of the last 5 Commodores, are politically insulated because they are not running for office and yet they are in the best position to know the quality of the job being done by a governor. They can act solely in the best interests of BLYC and are unlikely to exercise this authority except where it is needed. Agreement of the 5 Trustees is required by the proposed amendment.

Bar & Kitchen

Andrea has informed the Board of Governors that she will resign as manager of the BLYC effective September 27, 1996. The Board of Governors and I would like to thank her for all of her wonderful work and efforts over the last nine months. Her efforts have made our Club a better place to be. She has expressed interest in working in her previous capacity while she returns to college to further her education. Andrea has received many compliments and we hope that we can find someone who cares as much and is as willing to work for the betterment of the BLYC.

I also am leaving the job of Bar & Kitchen as election time of Club Officers rolls around again. It has been a pleasure to work with the Bar & Kitchen staff. I hope to be able to continue to serve the BLYC in the future.
