

Yacht Club Takes Trip; Yerke Takes Dip

On Friday, July 18th, a fleet of 5 BLYC boats, their captains, mates and crews, set out from Skipper Haven Yacht Club on the Ohio River in Toronto, Ohio, in the annual renewal of the Homer Tussing "Tween the Trees" Memorial Cruise.


Leading the fleet were Bob and Peg Yerke in "Buck-Aye," with son Mark and wife Patty aboard. Next in line were Commodore Fred and Ruth Wright in the most recent incarnation of "Wright Aweigh." Their crew was Tim and Martha Maite. Dick and Kay Wolf followed in "Sea Wolf" with son Matt and his friend Connie Elgin. Next were Ken and Mary Keller in "Pierless." Keeping an eye on the fleet from the rear were Jerry and JoAnn Boundy in "Dolphin" with crew Jerry and Tona Converse and Rennie and Judy Molino.

The 3-day, 138-mile round-trip cruise would progress up the Ohio River to mile marker 0 at the confluence of the Allegheny and Monongahela Rivers (in the shadow of Pittsburgh's Three Rivers Stadium), then turn north up the Allegheny to Fox Chapel Yacht Club where the fleet would spend Friday and Saturday nights. En route the boats would twice pass through 5 locks.

Highlights of the cruise included the now traditional toadrangling cloudburst with attendant electrical storm, and a magnificent Saturday night, full moon, no-wake cruise down river from Fox Chapel to Pittsburgh and return, including a 2:00 a.m., starlit passage through Allegheny Lock No. 2.

A curious feature of the cruise was Bob Yerke's seemingly spur-of-the-moment decision to stop dealing with matters on the bow of his boat and suddenly begin examining his underwater hull. This swift change of perspective was accomplished while "Buck-Aye" was moored at Fox Chapel . Bob's pants dried quickly enough and, ever resourceful, wife Peg purchased a still warm shirt from a bemused Fox Chapel guest's back. Properly re-attired, Bob never missed a moment of Saturday's dinner and moonlight cruise. And speaking of Saturday's dinner, it was made even more special by a visit from past-Commodore Chris Lambrecht and his wife Margene.



"Buck-Aye," too, may have run afoul of the weather and while she was able to complete the trip to Fox Chapel, her skipper elected not to chance pe long river trip home. Editor's Spotlight COMMODORE GUS SCHELL

Some may waste their lives taking endless aim,

Pull triggers and hit lots of targets



Gus Schell, a 56-year member of the BLYC, was elected Commodore in 1951. In 1975 he was named Com-

modore of Inter-Lake Yachting Association. That club has acquired 135 member clubs, located from Alpena, Michigan to Buffalo, New York. Inter-Lake Yachting Association had

just one other BLYC Commodore, Edgar T. Wolfe, 1937.

Genial Gus has been boating since 1940. His log embraces all kinds of water craft, organizations and events. In 1952, he Commodored Ohio Inter-Club Yachting Association. The record shows he is both a joiner and a doer. His clubs include Columbus Power Squadron since 1946 (with 43 merit marks), Agonis (President 1972), Navy League, Great Lakes Historical Society, Put-in-Bay Yacht Club, National Football Hall of Fame, Buckeye Sideliners, Buckeye Boosters, Crews Host, Columbus Maennerchor, Whitehall, Bexley Rotary, Blue Gavel, Columbus Home Plate Club, Columbus Power Squadron "Down River Pumping and Shouting Society," that has lunched Wednesdays at 14 different locations. BLYC was able to join ILYA by being located on the Ohio Canal System in 1906.

An ordinary man would find Gus' main occupation a complex chore. He owns and operates the Schell Scenic Studio. The business ships theatrical stage scenery (backdrops, lights, drapes and special effects) throughout the United Sates. Gus Senior started the business in Columbus in 1904 and is now in third generation. But not our inimitable Gus. For years he has sneaked off to the scenic home on Buckeye Lake's towpath, with his charming wife, Martha, and their lucky lad, Philip, who is now Vice President of Schell Scenic Studio.

Schell's personal fleet is as varied as his boating record. It now includes, 1948 Chris Craft Sedan Cruiser, the historic "K" Class "Catspaw" built by Leodke in 1931, Laser sailed by Philip 22-foot Boston Whaler and a DN iceboat, that sometimes dunks.


Several members of BLYC—Crites, Lambrecht, Wilson and Johnson—have enjoyed Gus' good fellowship on a cruise to Florida...down the Ohio and Mississippi Rivers and through the Intercoastal Waterway. Others have sailed with him to Mackinac. In 1973 and 1974, he was on the Port Huron-Mackinac Race Committee. Still others raced lightnings with him from 1945 to 1955.

For years, Gus was a leading tenor in SPEBSOSA Quartet singing, and his high tenor voice still festoons the Columbus Maennerchor. As the wife of the Put-in-Bay Police Chief will testify....he cuts a mean rug on the dance floor.



OFFICIAL MEMBERSHIP NOTICE

At a special meeting of the Board of overnors, held on July 16, 1997, the rollowing motions were passed by the majority of those in attendance and approved for publication in the August 1997 Log: (One Governor was absent.)

Motion 1 To make the necessary changes to the By-Laws to allow women members.

Motion 2 To adopt the Long-Range Planning Committee's recommendations for women members.

The next meeting of the Board of Governors will be held Thursday, August 14,1997, at the Buckeye Lake Yacht Club at 8:00 p.m.

REPORT OF THE 1996-97 BLYC LONG RANGE PLANNING COMMITTEE REGARDING THE WOMEN MEMBERSHIP ISSUES

The Long Range Planning committee recommends that the Board go cautiously to give full and complete consideration to all opinions and all consequences in the By-Laws and future policy in the event women are admitted to membership. However, we recommend that the issue be determined during the term of this board and not be postponed until after the elections.

II.

In the event women are admitted as members, the committee recommends the following changes in the By-Laws:

Distaff Membership

The By-Laws should expressly provide that all members who joined before the change should be grandfathered so no such mber or their wife loses any rights they now have. Their wives should retain the right to become distaff members as in the current by-laws. Grandfathered and presently existing distaff members should also

be permitted to become regular members if they request it, without paying initiation fee but paying regular dues.

As to members who join after the effective date of any change, Article I, section 8 should be changed as follows:

"Section 8. (a) In the event a married member becomes deceased, the spouse of the member may succeed to the member-ship upon request made within one year of the member's death and will become a member by continuing to pay all dues, fees and charges as they become due. In the event of such succession, the spouse shall be liable for all outstanding obligations of the deceased member and shall succeed to all privileges including rental facilities and dates of dock request letters of the deceased member but shall not succeed to an office held by the deceased member."

Women on Second Floor Article XI, Rule 10 This rule should be deleted.

Junior Membership Article I, Section 5

We should eliminate junior memberships, because they are generally ignored. We should permit all children of a member to join without initiation fee if they do so before age 21 or age 23 if they are a full time college student as currently provided in the By-Laws. They should be required to do so by submitting a letter requesting it before the deadline age.

Guest Privileges - Article VI

Mothers and unmarried daughters of members who joined prior to the effective date of a change should be grandfathered to retain their full time guest privileges. Mothers and unmarried daughters of members who join after an effective date should be treated like fathers and sons are currently treated- i.e., no guest privileges after they are age 21 or 23 (i.e., eligible for membership).

Language

A provision should be inserted in the By-Laws stating that all male pronouns shall be interpreted as generic to include persons of female gender.

Uniforms

The Board might want to consider adopting a uniform for female members.

II

The following should not be changed.

There should be no family memberships. All memberships should be individual. The family of members should still have the same privileges as currently provided except as recommended above. Whoever is the member can vote and hold office. The rest of the family cannot. The membership cannot be transferred except upon death of the member as provided above. The non-member spouse can, if he or she wishes, join in the usual manner.

Pertinent Articles of the By-Laws ARTICLE X AMENDMENT OF BY-LAWS

Prior to amending the By-Laws, a proposed amendment to the By-Laws must be presented at a meeting of the Board of Governors, approved by that Board for publication in the Log, and have its substance published in the Log at least one week before it is considered. Thereafter, the Board of Governors may act upon the proposed amendment, including amending it.

ARTICLE VI DUTIES OF OFFICERS

Section 7(e) - The Governors shall have the authority to make and enforce such by-laws, rules and regulations for the government of the Club as they deem necessary.

ARTICLE VIII MEETINGS

Section 3(a) - Twenty percent (20%) of the eligible voting members in good standing shall constitute the required quorum at any regular or special meeting, and a simple majority shall determine the issue(s) involved, except as otherwise provided.

(b) - A two-thirds (2/3) majority of those eligible voting members present shall be required to reverse any Board of Governors' actions.
