The goal of the Membership Committee is to recruit and retain members. We continue to monitor the expected level of service and the use of the facilities by our members. The Board of Governors implemented the following policies and practices to help alleviate use of our facilities by non-members and to maximize the enjoyment of our Club by our members.

1. We reduced number of nonresident members from 14 to 6 by enforcing our By-Laws and charging full fees to all who live within 75 miles of the Club.
2. BLYC closed the use of our pool to those requesting reciprocity.
3. The Board of Governors did not permit pool parties except those that the Club sponsored as an event. This included several entertainers and a pool party for adults only.
4. Our swimming pool is still crowded on hot days. We requested that our members voluntarily sign in as the signs that have been there for years indicate. Only about 20% of our users signed in.

5. The use of the keycards on all docks, the parking lot, and the island has significantly reduced the use of our Club by non-members. This includes impromptu pool parties by adult children of members and former members.
6. Guest parking and Club access is granted by a one time only number that is good for one day only. When making reservations, request a number for your guests. The office and the bar can give it to you at any time during business hours.
7. Most of our members are making lunch and dinner reservations. You can call the office or make them online at the website, [www.buckeyelakekeyc.com](http://www.buckeyelakekeyc.com)
8. We want to remind you that children under the age of 21 and/or 23 if in college are considered children that have use of the Club facilities. Over age 21, they are adults and are not permitted to make reservations or use the facilities except as your guest. The Club has a program of reduced rates for your adult children under 40. It is spelled out online in the By-laws. If they still enjoy the Club, it is time for them to become members.
9. A reminder that guests can only come three times during the year. This means that they can come with you and all other Club members combined three times. Guests are not permitted unless you are with them.
10. Only members can make reservations.

Buckeye Lake Yacht Club has a wonderful legacy of family involvement and membership. This year we lost 4 of our significant members that contributed to that legacy as leaders and

friends.

At the start of the Club year, we lost Commodore Bob Zeiher. Bob first served on the board in the early 1980's and later returned, serving another five years, and was our Commodore in 2012.

This spring, we lost Joan Hein who was associated with the Auxillary as a President, volunteer, and longtime supporter and member. Joan was the "First Lady" of our sailing program, the daughter of Commodore Robert E. Dye and wife of Commodore Michael Hein, and the mother and grandmother of one of our Club's finest sailing families. All of her children and most of her grandchildren were junior sailors for BLYC.

This summer, we lost our Fleet Chaplain, Father Michael Gribble who was the spiritual leader of our Club and blessed our fleet each year. He was a friend to all and married and/or taught many of our members.

This past month, we lost our most senior continuous member and another of our sailing icons, Marty Headlee. Marty joined as a teenager at age 14. He met his wife Sue at BLYC sailing camp. They sailed competitively in the Lightning Class and passed on their enthusiasm for sailing to their children and grandchildren, all of whom were Junior Sailors for BLYC.

Our Club and lives were enriched by each of these precious people. May Heaven be enriching as well. God bless their families.

# HOUSE & GROUNDS

This Here we are half way through October and as most of you may know, the club held its election of officers this past Sunday on September 18th. I want to take this opportunity to thank all of those people who voted for me to retain a position on the board. For the upcoming year, I will continue my duties as House and Grounds Governor as well as the duties of Rear Commodore. I would like to cover in this article what House and Grounds has achieved in the past year and offer some thoughts on the coming year. Keep in mind all of these projects were completed through a group effort. Since coming into the position in September of 2021 we have completed the following:

- the new tile floor behind the bar
- the sea wall and docks on the east side of the island
- the razing of three silver maples in front of the rental house
- installation of security gates in the parking lot, the bridge, and docks
- installation of directional markings in the parking lot
- rebuilt the pool bar wall
- demolition of the garages in the parking lot
- painting the exterior of the club
- completed the repairs required by our insurer's inspection of the premises
- installation of a new pool cover for the winter season
- installation of a natural gas fireplace insert with glass doors
- changing the rental house to a storage facility

As you may recall, our tenants moved out of the rental house in the beginning of July and we have spent some time effecting needed changes to turn it into a functional storage facility. As you maybe aware, storage space at the club is at a premium and this should go a long way in easing that congestion. The pictures below will demonstrate the condition of the house prior to and after the improvements were made. The clean up day held on this past October 2 focusing on cleaning up the club also included moving numerous items into the new storage facility.

While we have accomplished much in the

past year, our biggest and most impressive project will be the rebuilding of the south side of the island and the south basin.

If everything goes to plan, we should be able to start construction at the beginning of November. Unfortunately, due to the enormity of the project, it will not be completed by the summer season. This will necessitate the club finding dockage for those boats currently located in the south basin.

There'll be more information forthcoming on this matter. Other projects include replacement of the exterior steel staircase in the back of the club as well as the interior updating the the lake view dining room. I want to thank you for the opportunity to once again serve as your House and Grounds Governor and I look forward to working in that capacity and as Rear Commodore in the coming year.

# LOOKING AFT

All BLYC members living today have only known one clubhouse, our stately Victorian-style structure that has been an iconic landmark at the lake for many years. Some are aware of the original Clubhouse built along the east side of the island over the water. It has been gone since around 1913. Few know the story however of the clubhouse that was originally planned for in 1907 when the fledgling BLYC first secured the lease on what we know now as Watkins Island. This month, I share Commodore Foster's 1986 article on this very topic.

## The Clubhouse that Never Was

I just obtained forty-eight 8x10 photographs from Chance Brockway. I have a lot of material and want to begin sharing a little of it with you right away, plagiarizing heavily from Kyle Armstrong's book, *Story of Buckeye Lake Yacht Club*.

In 1906, the year the club was formed, it had neither a clubhouse nor a location. Shortly after Labor Day, 1906, Governor Mooney and others attempted to negotiate to obtain Castle Island. However, when its lessee learned of club attempts, he paid up his back rent so club officials had to look elsewhere. At a Tar Social on January 15, 1907, the business included erection of a club house. About 70 members and guests were present, paid \$1.00 a head and held the meeting following "plenty to eat and drink." During the meeting, slides of various styles of boats and boathouses were described and Commodore Lynch circulated subscription papers obtaining signatures of those who would agree to purchase a share of "stock" in a clubhouse at \$5.00 per share.

Soon thereafter, on January 24, a corporation was formed "for profit" called the Buckeye Lake Building Company. Capital stock was set at \$5,000, divided into 1,000 shares at \$5.00 per share. Its purpose was constructing and erecting buildings at or in the vicinity of Buckeye Lake to be used for

boathouses, clubhouses, and similar purpose, and to acquire land and hold real estate necessary therefor; to build and equip, rent or sell, sail, row, or power boats; to erect and construct docks and wharves; provide harbors and anchorage facilities for boats; and all other things necessary or incidental to the execution of the afore said objects. The purpose was to provide facilities for use by BLYC on a rental basis and freeing individual members from personal liabilities.

Incorporators met and the first directors were selected on March 25, 1907. Subscription to the shares was open only to BLYC and its members. At this time the incorporators found that 30 members had subscribed to shares in lots of 1 to 20, the total number of shares subscribed being 116. Officers of the corporation were selected and \$200.00 was borrowed from BLYC to pay for bills and expenses incurred to date, to be repaid to the club from the company's treasury, when possible. A firm of Columbus architects were commissioned to prepare working drawings and specifications for structures to be built at the lake and rented by the corporation to the club. Between January and March of 1907, the incorporators had taken over a lease on an island and a half lot on the lake's main shore facing the island. The island was known as Sunken Island, which was often water covered and had several half grown trees, mostly willows, surrounded by always shallow water. They determined that it could be raised and enlarged and the waters around it could be deepened by scraping onto the island the material from the adjacent bottom. We now call it Watkins Island.

This island was at mid-lake and was surrounded by water so it seemed that it would afford both desirable privacy and unobstructed view in all directions. It was located near a wagon road and only

about 300 yards from the Interurban Railway's lake terminal. It would be conveniently accessible, especially with a footbridge that could span the 200 foot strip of swampy channel separating it from the lake's north embankment. The architects were to make preliminary sketches showing suitable improvements on Sunken Island. Those sketches were the basis for commissioning of these architects in March. Preliminary sketches were presented at that time and published in the newspapers and pictured Sunken Island as high and dry; a covered footbridge leading to it from the mainland; a boat house for powercraft along its east shore; and covering most of the island area a fine clubhouse fronting southward at the water's edge. The clubhouse was depicted as a rustic, slab-sided casement windowed, two story structure with steeply pitched hipped, gabled and dormered roofs of wooden shingles. Long main roof slopes extended downward over three separate porches facing westward, southward, and eastward, the last of which continued beyond the rear of the building to the main shore as the covered footbridge. High above the lofty rooftop stood a square tower, tapering upward, crowned by a bracketed, balustered, look-out balcony facing all sides around the large, cylindrical, wooded water storage tank.

Within its first story were a great hall with inglenook and field stone fireplace; separate spacious reception and retiring rooms for members and their ladies; a single story wing for dining and kitchen purposes, to the west and to the rear of the porch on that side; and a locker room at the base of the look-out tower at the rear. In the second story there were sleeping rooms for members and male guests; and the high attic above provided storage space for yachting gear.

With the working drawings and the specifications completed, bids for its constructions were obtained and on May 8, 1907, proposals from five bidders covering the entire project were opened. Upon their consideration all were rejected. While the club had grown to a membership of over 100, sale of stock was lagging behind that expected. The directors deemed it prudent to confine the company's immediate development to bare necessities more nearly within the corporation's limited potential means. Accordingly, a committee was created and directed to secure new bids on boathouse, bridge and related items only, making alterations in plans and specifications considered feasible while keeping costs at a minimum.

The above is a condensation of the account of Kyle Armstrong. The photograph shows an article published in a Columbus paper on March 31, 1907 and showing the officers of the Yacht Club and the building committee and, very interestingly, a drawing illustrating the proposed clubhouse which was described above. As you will see in later articles, and as is apparent from Kyle Armstrong's account, the proposed house was considerably more expensive than the yacht club could afford, so they built a considerably less expensive clubhouse and the boat houses which stood where our covered docks now stand and which were torn down only in the last decade. (Editor's Note: The "new" covered docks being torn down last year) I have several pictures of it for another day. Later, these plans obviously influenced the later design of our current clubhouse.
